Full payment (CHECKS ONLY) of the vendor fee is required to reserve space. Full payment is due by September 22, 2011. Refund policy: MainStreet Truth or Consequences will only make deposit refunds with written notice prior to September 9th, 2011. After that date absolutely no refunds will be made for any reason.

MainStreet Truth or Consequences must have full payment and forms on file prior to vendor being allowed to set up and/or operate. Mail to MainStreet Truth or Consequences, ATTN: Vendor Coordinator, P.O. Box 1602, Truth or Consequences, NM 87901 or email to manager@torcmainstreet.org.

Subletting or sharing of vendor space is strictly prohibited. Entirety of vendor's set-up, display, and working space must be within the space rented. If you need more than the 10'x10' space, you must purchase an additional space.

Set-up/ Hours of Operation/ Teardown

Hot Springs Festival is held on Foch Street between Broadway and Main in downtown Truth or Consequences. Vendor Set-up begins at 9:00am. Tear down must be completed by 8:00pm. Vendors are expected to operate for the whole event. (Noon to 6:00pm)

No generators allowed. Heavy duty electrical cords only. (Power cords will be subject to inspection by city electric department.) Vendor will need to supply their own tables, chairs, displays and tents, as necessary.

Insurance and hold harmless

All vendors and exhibitors must have their own liability insurance. Vendor is solely responsible for all dealings and actions, and holds MainStreet Truth or Consequences harmless from all claims.

Legal Compliance/ Taxes

Vendor agrees to comply with all laws, licensing, permits, and health department regulations. Vendors are solely responsible for payment of all state and local sales tax as a result of any sales made during this event.

Product Restrictions

The sale and/or display of merchandise bearing the words "Hot Springs Festival", "MainStreet Truth or Consequences" or any other variations related to this event is strictly prohibited.

Questionable Products

MainStreet Truth or Consequences reserves the right to inspect, approve, reject or otherwise control the display, promotion or sale of products or services at its sole discretion. Illegal drugs and drug paraphernalia, toy or real weapons, fireworks, flea market or garage sale items, stink products, merchandise of a racial nature, obscenities or products of an offensive nature of any kind will not be permitted. Any objectionable items must be removed from the booth by the vendor or may be removed by MainStreet Truth or Consequences.

Termination of agreement

MainStreet Truth or Consequences reserves the right to terminate this agreement at any time without prior notice if the terms of this agreement are not met or any policies are violated. Specific policies are:

Conduct and activities specifically not allowed, lewd behavior or the encouraging of lewd behavior, foul or offensive language, nudity, serving or consuming alcoholic beverages in vending space, drug use, intoxication or other illegal activities, violation of terms of this contract, laws or ordinances, fire department regulation or codes, or health department regulations.

Disclaimer

In the event that the Hot Springs Festival must be cancelled or rescheduled due to circumstances beyond our control, vendor fees will be applied to an alternate date or event as determined by MainStreet Truth or Consequences. No refunds will be made.
